Summary	 A. Everett Austin's records document the initial development of the John and Mable Ringling Museum of Art as a public museum. The records reflect Austin's tremendous impact on the Museum which includes: initiating an art conservation program; establishing a vigorous acquisition policy; renovating of the art galleries; ground-breaking exhibitions; purchasing and installation of the Asolo Theater; hosting professional theatrical and operatic productions; conducting educational programs

first museum dedicated to the history of the circus; and opening to visitors the Ca'd'Zan, the residence of John and Mabel Ringling. Correspondence documents the wide range of Austin's interests. Of special notice in are his director reports and those of the State Board of Control.

Historical Note

Austin was appointed as the museum's first Director by J. Thomas Gurney, Chair of the Florida State Board of Control, following the transfer of the Museum to the State in 1946. Austin had previously been the Director of the Wadsworth Athenaeum in Hartford, Connecticut, for eighteen years. Austin remained as the Museum Director of The Ringling until his death in 1957.

Chick Austin was born in Brookline, Massachusetts. He attended the Noble and Greenough School and Phillips Academy. Before entering Harvard

Austin was on the cutting edge of the art world in the 1930s. He arranged three major exhibitions to the American audience for the first time: a Picasso a Surrealist art exhibition and a comprehensive Italian Baroque painting exhibition. His interest in the arts extended into the performing arts. He was instrumental in choreographer George Balachine's immigration to the United States and subsequent development of Ballanchine's School of American Ballet.
